THIS AGREEMENT IS SUBJECT TO ALL TERMS AND CONDITIONS APPEARING ON THIS CONTRACT. IF THERE IS A FEE TO PARK THAT FEE WILL BE COVERED BY THE CLIENT AND PAID FOR BEFORE EDITS ARE DELIVERED. OUT OF STATE TRAVEL & LODGE CHARGES WILL BE PAID FOR BY THE CLIENT 24 HOURS PRIOR TO THE SHOOT DATE. THE CLIENT SHALL MAKE A DEPOSIT TO RETAIN THE PHOTOGRAPHER TO PERFORM THE SERVICES SPECIFIED HEREIN. THE RETAINER FEE IS 50% OF THE TOTAL. AT SUCH TIME AS THIS ORDER IS COMPLETED, THE DEPOSIT SHALL BE APPLIED TO REDUCE THE TOTAL COST AND CLIENT SHALL PAY THE BALANCE DUE. IF THE CLIENT REFUSES DELIVERY OF THE ORDER OR REFUSES TO PAY THE DAY OF THIS ORDER, CLIENT SHALL NOT RECEIVE THEIR PHOTOGRAPHS UNTIL FULL AMOUNT IS PAID WITH A 10% INTEREST.
